The Ashley-Grand and Tempur-Pedic Holiday Mattress Giveaway Contest Rules

These contest rules are specific to the above contest conducted by Entercom Virginia, LLC d/b/a WNVZ-FM (the "**Station**"). Except to the extent specifically set forth below with respect to this specific contest, the Station's general contest rules apply to this Contest as well. A copy of these specific contest rules and the Station's general contest rules are available on the Station's website at https://z104.radio.com/rules. As a preventative measure in light of COVID-19 (Coronavirus), copies of the specific Contest rules and the Station's general contest rules will not be available at the Station's studio. To the extent that the Station's general contest rules differ from these rules, these rules will govern and control with respect to this contest.

How to Enter

- 1. No purchase or payment of any kind is necessary to enter or win the Ashley-Grand and Tempur-Pedic Holiday Mattress Giveaway contest (the "**Contest**").
- 2. Eligible Nominees must both be eighteen (18) years of age or older and legally reside in Virginia or North Carolina as of the date of entry in this Contest (each a "**Nominee**").
 - a. Individuals may make Nominations (each, a "**Nominator**") starting at 12:00am EST on Monday, November 23, 2020 and ending at 11:59pm EST on Sunday, December 20, 2020 by means of submissions to the Station by completing the form on the Station's website by clicking on the "Ashley-Grand and Tempur-Pedic Holiday Mattress Giveaway" page and submit all of the following materials:
 - i. Nominator's contact information including Nominator's full name, address of legal residence, phone number (including area code), date of birth, select a gender, and e-mail address.
 - ii. The name, address, age, and telephone number (including area code) of the Nominee that you are nominating in this Contest; and
 - iii. A short essay in 250 words or less describing why Nominator would like to nominate someone who is a first responder or essential worker (each a "**Nomination**").
 - 1. Nominators may not nominate themselves.
 - 2. Nominators are not eligible to win or receive a prize in this Contest.
 - 3. Only the first 250 words of any essay submitted will be read (longer essays will not be disqualified).
 - By submitting an essay to the Station, each Nominator authorizes the Station to post such essay and/or Nominator's and Nominee's name to the Station's website at <u>https://z104.radio.com</u> and/or to read it onair.
 - c. Station reserves the right to edit an essay in its sole discretion. Not all essays will be posted to the Station's website and/or read on-air.
 - d. Essays need not be truthful. Station shall have no obligation whatsoever to verify the truthfulness or accuracy of any essay submitted in this Contest, even if such essay is submitted with an entry selected as the winning entry.
 - e.  - f. As part of the entry process, Nominator may be provided with an opportunity to opt-in to receive solicitations from, and/or to become a member/participate in clubs of (*i.e., email clubs, text clubs, and rewards programs*), the Participating Stations; provided, however, agreeing to receive such solicitations and/or accepting such membership is not a condition of entry into this Contest and will not increase your chances of winning.
- 3. By submitting a Nomination, Nominators and Nominees understand and agree that Station may elect to use any submitted Nomination for entertainment purposes on-air and may choose to "make fun" of any submitted Nomination. Nominators and Nominees waive any right to make any claim against

How to Win

- 7. At approximately 12:00 pm EST on Monday, December 21, 2020, twenty (20) Winner(s) will be randomly selected from among all of the entries in this Contest to receive one (1) Prize in this Contest (*as described in Section 11 below*), subject to verification and compliance with the Contest rules (the "**Winner**").
 - a. There will be up to, but in no event more than, twenty (20) Winner(s) in this Contest.
 - b. The Station will notify the Winner(s) by means of the phone number or email address provided to the Station at the time the Nominee entered the Contest.
- 8. Odds of winning the Prize in this Contest shall depend upon the number of entries received in the Contest.
- 9. PRIZES WILL BE AWARDED TO THE SELECTED NOMINEES WHO WILL BE THE ONLY PERSONS ACKNOWLEDGED AS WINNERS IN THIS CONTESTS. THE NOMINEES WILL BE REQUIRED TO COMPLETE THE NECESSARY FORMS REQUIRED BY STATION (INCLUDING, WITHOUT LIMITATION, ACKNOWLEDGEMENT OF RESPONSIBILITY FOR TAXES, PROOF OF AGE AND RESIDENCY) PRIOR TO RECEIVING THE PRIZE. Prizes

11. Up to twenty (20) verified Winners will receive the Prize described below ("Prize"). The Station reserves the right to award fewer Prizes in the event that an insufficient number of entries are received. Each Prize consists of one (1) certificate ("Prize Certificate") which the winner may redeem (as specified herein and in the Prize Certificate) for one (1) Tempur-Pedic queen-size refurbished donation mattress and one (1) queen-size box spring (box spring brand to be determined by Jerry's, Incorporated in its sole discretion). The retail value of each Prize is \$2,262.47. A "refurbished donation mattress" is a mattress that has been returned to Tempur-Pedic® through the Tempur-Pedic® 90 day comfort return program and has undergone the Tempur-Pedic® National Donation Program refurbishment process wherein the mattress is inspected to determine if it is usable, the original cover and fire sock are removed, the mattress core is sanitized with Steri-Fab, and the sterilized mattress core is covered with a new fire sock and a new donation cover. During this process some mattresses are cut down to size based on charity demands and core availability, and as a result, they are not "End of Life" mattresses, meaning they are not fully comparable to any specific Tempur-Pedic® model.

- 12. Each Prize will be awarded in the form of a certificate ("Prize Certificate") that Winners must redeem directly from Jerry's, Incorporated at a participating designated Grand Furniture and Ashley HomeStores retail location (as specified on the Prize Certificate) no later than February 1, 2021. Winner(s) forfeits the Prize if Winner(s) does not redeem the Prize Certificate from Jerry's, Incorporated by February 1, 2021 as specified herein and in the Prize Certificate.
- 13. Winners acknowledge and agree that Station's only obligation with respect to the Prize is to award a Prize Certificate to verified Winners who have completed all requirements to receive the Prize.

Sponsor(s)

16. The administrator of this Contest is Entercom Virginia LLC d/b/a WNVZ and the sponsors of this Contest are Jerry's, Incorporated d/b/a Grand Brands and United Way of South Hampton Roads.

Other Rules Specific to This Contest

- 17. Station is conducting this Contest using proprietary software owned by a third party known as Second Street Inc. ("Second Street"). Second Street is not a sponsor of this Contest but entrants may be required, as part of the entry process, to agree and consent to Second Street's Terms of Service and Privacy Policy (both of which are available via a link during the Contest entry process) (collectively, the "Second Street Policies") and may be required to register with Second Street. While agreement to the Second Street Policies is required in order to enter this Contest, the Second Street Policies are not a part of these Contest rules but are a separate agreement between the entrant and Second Street. With respect to the conduct of this Contest by Station, in the event of any conflict between the Second Street Policies and the Station Contest rules, the Station's Contest rules govern.
